- **Wedding Package:** Snyder Photography (here after SP) will provide up to 8 Hours of coverage, capturing candid and formals. Proceedings are possible bride finishing getting ready, ceremony, formals, and reception. There will be no limit or guarantee to the number of photos captured, the average is 200-600. High resolution digital files will be provided on a professionally printed DVD in a professionally printed canvas DVD case will be the final product (One included, extras \$100/each). A PDF granting print rights allowing you to print your photos however you want, from where ever you want, will also be on the DVD. All photos will be professionally color & brightness corrected on fully calibrated displays. All formal photos will also be professionally edited to make sure you look as beautiful as possible in your photos. A single professional, experienced photographer, will handle the entire photo process (capturing, correcting, editing, DVD/Case Design). A single assistant to allow the photographer to 100% focus on his job. The final product shall be ready for the client in a 4-6 week time period. Client shall receive 50% off a \$100/1 hour engagement session with down payment. Client shall receive a free future 1 time \$100/1 hour maternity session. Client shall receive a family discount of 10% off all future prints and services for any portraits of any member of client's household (living in your house at the time photos are taken).
- **Payment & Reservation:** A down payment of \$375 is due in order to reserve a date. They down payment is not refundable for cancellation of the wedding regardless of reason. If the date is moved, but not cancelled, all amounts paid will remain. However if client wishes to move the date to a date that SP is already booked, client will forfeit their down payment. The full amount owed is due no later than 1 week prior to the date of the wedding.
- **Final Overview:** Client must finalize all information on the first page of the contract no later than one week prior to the wedding. Any changes after that time are at SP's discretion.
- **Event Guide:** The client will be responsible for (or have someone designated for this responsibility) identifying people/objects of whom/which specific photographs are desired. SP will NOT be held accountable for not photographing desired people if there is no one to assist in identifying or gathering people for the photograph(s).
- **60 Minute Window:** In order for SP to perform needed formal photos; client agrees to provide at minimum 60 minutes of SHOOTING time. This starts once the photographer starts to shoot. This does not include time traveling to the formal location or time gathering the bridal party and desired family. Client is responsible for notifying and gathering the bridal party and desired family for the formal photos.
- **Cooperation:** SP is not responsible for key individuals' failure to be present or to cooperate during photography sessions, neither for missed images due to details not revealed to SP. SP recommends that the client designate an "event guide" (see Event Guide above) to point out important individuals to the photographer, whom the client wishes to include in informal or candid photographs.
- **Time Frame:** SP shall not be held responsible for missed photos due to events not starting or finishing on time.
- **House Rules:** SP is limited by the guidelines of the ceremony official or the reception site management. The client agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for modification of guidelines is the client's responsibility.
- **Reception Seating:** SP and an assistant will be with the client for the entire day. Due to this the client agrees to provide SP with two seats & meals at the reception.
- **Model Release:** The client hereby assigns and grants SP and its legal representatives the irrevocable and unrestricted right to use and publish photographs of the client or in which the client may be included, for editorial, trade, advertising or any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The client hereby releases SP and its legal representatives and assigns from all claims and liability relating to said photographs. It is agreed that SP may display and use the photographs taken for advertising, display, website and internet promotion, photographic contests, public display such as in malls, photography books, photography instructional books, store fronts, window displays, studio display, television advertising, magazine advertising and any other purpose thought proper by SP.
- **Exclusivity / Guest Photography:** It is understood that SP will act as the sole and exclusive wedding photographer. Because of the fact that flashes from guest's cameras may ruin shots taken by SP, the client acknowledges that they are responsible for notifying all of their guests that guest flash photography is not permitted at any time while the professional photography is in session. SP suggests that a separate notice be placed in the invitations. The formal photography time is for the exclusive use of SP to capture the formal wedding portraits. Because of time constraints and the need for subjects to pay full attention to the professional photographer, guest photography cannot be permitted. SP will allow guests to take snapshots during the processional and recessional, during candid events at the location. SP shall not be held liable for lose of quality of photos due to guest's flashes or any guest interference.
- **Equipment Lose:** SP will take every precaution in keeping its equipment protected. However in the case that equipment is damaged or stolen by anyone not employed by SP; the client is 100% responsible for its replacement and/or any loss of photos due to said issue.
- **Limit of Liability:** In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. SP will make every effort to secure a replacement photographer able and/or willing to provide a similar package as chosen in this contract at the same/similar tariff. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. SP takes the utmost care with respect to exposure, transportation and processing of photographs; including using professional grade equipment and professional grade backup equipment. However, in the unlikely event of the client's photographs being lost, stolen or destroyed for reasons within or beyond SP's control, the latter's liability is limited to the return of all payments received for the event package. The limit of liability shall not exceed the contract price stated herein. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.
- **Amendments:** This contract has been freely negotiated and shall be recognized as the entirety of the agreement. Only those changes or modifications specifically placed in writing, attached, dated and signed by the client and SP at the time of acceptance of this contract shall be recognized as amendments to this contract.
